



Liability Waiver, Release & Indemnity Agreement – Padel Court Booking

By completing your booking and using the facilities at Tower Hill Terrace, you confirm that you have read and agree to the following terms on behalf of yourself and all other participants included in your booking (collectively referred to as “Participants”):

1. Assumption of Risk

You acknowledge that padel is a physical sport that carries inherent risks, including but not limited to injury, falls, collisions, or damage to personal property. You voluntarily accept these risks for yourself and all Participants included in your booking and agree that your use of the Padel facility is entirely at your own risk.

2. Waiver and Release of Liability

You, for yourself and all Participants, waive and release Central London Alliance and Tower Hill Terrace, its owners, staff, affiliates, and agents from any and all claims, demands, liabilities, and damages that may arise from or relate to the use of the court or facilities, including any injuries, losses, or property damage, whether caused by negligence or otherwise.

3. Indemnity

You agree to indemnify, defend, and hold harmless Central London Alliance and Tower Hill Terrace, its owners, employees, and agents from any claims, costs, damages, and expenses (including legal fees) arising out of or relating to:

- Your use, or the use by any Participant, of the padel court or facilities;
- Any failure by you or the Participants to comply with posted rules or safety instructions;
- Any act or omission by you or the Participants that results in injury, damage, or loss.

This indemnity obligation applies whether or not Central London Alliance and/ or Tower Hill Terrace is alleged to be negligent.

4. Responsibility for Participants

As the person making the booking (“Court Booker”), you confirm that:

- You are authorised to act on behalf of all Participants included in your booking.
- You have obtained their consent to be bound by this waiver, release, and indemnity agreement.
- All hired equipment must be returned after use. If any equipment is lost, damaged, or not returned, the user agrees to pay the cost of repair or replacement and authorises us to charge the card on file accordingly.



- You accept full responsibility for ensuring that all Participants comply with these terms and with all rules of the facility.

You agree that you are fully liable for any breach, injury, damage, or misconduct by any Participant in your group.

5. Rules and Conduct

All Participants must follow posted rules and behave in a safe, respectful manner. Central London Alliance and Tower Hill Terrace reserves the right to cancel or terminate play without refund in the event of unsafe, inappropriate, or non-compliant conduct. All players must wear appropriate sports clothing and protective equipment.

6. Health and Fitness Declaration

You confirm that you and all Participants are in good physical condition and fit to play padel, with no known health concerns that could pose a risk during play.

7. Minors

If any Participant is under the age of 18, you confirm that you are their parent, guardian, or have their guardian's authority, and you accept full responsibility for their participation.

By completing your booking, you confirm that you have read, understood, and agree to this Liability Waiver, Release & Indemnity Agreement, and that you accept these terms on behalf of all Participants included in your booking.
